User Agreement School Locker Haarlemmermeer Lyceum

## Disclaimer

The user agreement is a translation from Dutch. The text of the Dutch user agreement remains authoritative.

## 1. Agreement

## Article 1

In order to make free use of the school locker, the user agrees to this agreement of the Haarlemmermeer Lyceum. Part of this agreement includes these User Agreement School Locker and the Terms of Use School Pass Haarlemmermeer Lyceum.

## Article 2

In these terms, the user refers to the student enrolled at the Haarlemmermeer Lyceum who is not outsourced. Only one user can use one locker at the Haarlemmermeer Lyceum.

## Article 3

The rights and obligations under the agreement are not transferable.

## 2. Duration

## Article 4

The agreement is entered into for a specific period until the end of the current school year (exam week) and until the day the student is enrolled at the Haarlemmermeer Lyceum or until the day the outsourcing agreement takes effect.

## Article 5

Upon inspection at the end of the school year, the locker must be clean and empty. If a full and/or dirty and/or damaged school locker is found, a fee may be charged.
3. Use

## Article 6

The user must ensure careful use of the locker:

- The school locker will be continuously locked.
- The school locker will only be used to store outerwear, gym clothing, personal belongings, school materials, and/or a (motor)bike helmet.
- It is prohibited to store weapons, (soft) drugs, explosive, flammable, or otherwise dangerous and/or harmful substances in the school locker.
- Damages caused by the user's negligence or misuse by the user are the responsibility of the user.
- The school locker must be empty at the end of the exam week. If a full and/or dirty school locker is found, a fee may be charged.
- For safety reasons, the school management reserves the right to open and inspect the school locker preventively and at any time if suspicion arises.


## 4. Access to the Locker

## Article 7

Access to the school locker is granted by the Haarlemmermeer Lyceum on days when the Haarlemmermeer Lyceum is open during the hours designated for the user. However, the school reserves the right to deny access to the school locker outside the opening hours on school days, as well as in case of special circumstances.

## Article 8

The school pass is strictly personal and may not be provided to third parties (see the Terms of Use School Pass Haarlemmermeer Lyceum).

## Article 9

The user may not sublet the locker to another person or otherwise allow another person to use the locker without the permission of the Haarlemmermeer Lyceum.

## Article 10

The locker is opened by the user using his personal school pass/key. If a student loses his school pass/key or leaves it in his locker, the school locker can be opened by means of central control/key with the cooperation of the Haarlemmermeer Lyceum. This can be done at scheduled times.

## Article 11

- If the user loses the school pass/key or if it is stolen, the user must report it immediately to the Haarlemmermeer Lyceum at the counter in the auditorium.
- In case of school pass/key loss, the Haarlemmermeer Lyceum will provide a new lock/key for a fee of $€ 5.00$.
- If this happens, the loss/damage to the locker content is the responsibility of the user until the moment of reporting.


## Article 12

For safety reasons, the school management reserves the right to open and inspect the school locker at any time if necessary.

## 5. Termination and Termination

## Article 13

The Haarlemmermeer Lyceum is at all times authorized to terminate the user agreement without any notice period and without any other liability.

## Article 14

The school locker must be empty at the end of the user agreement. If a full and/or dirty school locker is found, a fee may be charged.

## 6. Liability

## Article 16

It is forbidden to store weapons, (soft) drugs, explosive, flammable, or otherwise dangerous and/or harmful substances in the locker. If damage occurs to goods or persons due to the content of the locker, the user is fully liable

## Article 17

The Haarlemmermeer Lyceum generally disclaims liability for any damage arising from either immaterial or material causes occurring outside the obligation of the tenant.

## Article 18

If the user does not adhere to these product conditions, the user is liable to the Haarlemmermeer Lyceum.
